

INFORMATION ON THE PROCESSING OF PERSONAL DATA (Section 13 of EU Regulation no. 2016/679)

ICSC Foundation - Italian Research Center on High Performance Computing, Big Data and Quantum Computing ("ICSC") informs the user (the "Data Subject"), for the purposes and in accordance with EU Regulation No. 2016/679 ("GDPR"), that they have directly provided their personal data—such as, by way of example but not limited to, name, surname, email addresses, telephone numbers, etc. (the "Data") — in order to gather training needs for AI skills development and receive updates on AI training services provided by the IT4LIA AI Factory project. ICSC confirms that the processing of the Data is carried out in compliance with the aforementioned regulation and in accordance with the resulting rights and obligations, and that:

- a) the controller is ICSC Foundation National Research Center in High Performance Computing, Big Data and Quantum Computing, represented by the General Director Dr. Daniela Gabellini.

- b) the processing of Personal Data is aimed solely at allowing the Data subject to updates on AI training services provided by the *IT4LIA AI Factory* project;
- c) refusal by the Data subject to communicate his/her Personal Data will not allow the transmission of Newsletters by the Controller;
- d) The Data may be disclosed to collaborators, persons in charge of the Data Controller, and partners of the IT4LIA AI Factory project, as well as generally to all parties to whom disclosure is necessary for sending the Newsletter and communications carrying out the activities contained therein;
- e) Personal Data are not transferred outside the European Union and are kept as long as the Data subject wishes to receive the Newsletters, save for that Personal Data which is necessary to enforce or defend any rights in legal proceedings or for the purposes of complying with tax, accounting and administrative laws and regulations or for the purposes of complying with other obligations under national and/or EU law.
 - The processing of Personal Data may be carried out using electronic and/or automated instruments which allow the storage, management and transmission of such Personal Data; however, the above instruments shall always be organised in such a way as to guarantee the maximum confidentiality and the necessary protection of the Personal Data;
- f) the Data subject may exercise the following rights provided by the Regulation (Sections 15, 16, 17, 18, 19, 20, and 21), i.e. the right to: (i) have access to Personal Data concerning the data subject; (ii) rectification of Personal Data, updating of Personal Data, have incomplete Personal Data completed, erasure of Personal Data, restriction or portability of Personal Data; (iii) object data processing; (iv) withdraw consent to the processing of Personal Data (in the latter case, it will be no longer possible to send any communication to the Data subject) and (v) lodge a complaint with the Autorità Garante per la Protezione dei Dati Personali (Italian Data Protection Authority), following the instruction and procedures publicly available at www.garanteprivacy.it;
